In the fall of 2000, George Vermilya along with other local estate planners was invited to participate in a fundraising event at Miriam's House. As George ate his breakfast that morning he listened to the stories of a few residents and was very impressed with the women and the successes they had achieved during their time at Miriam's House.

George takes pride in supporting Miriam's House because he understands that "life isn't perfect" and "couldn't imagine what it would be like to be homeless and not to have the security of a home for his family". He praises Miriam's House because it isn't simply a shelter; it helps the residents to develop the necessary skills needed for independent living.

George has enjoyed the personal interactions he has had with residents during his time as a Board Member; such as the recent Thanksgiving Dinner he was able to share with the residents. Events such as the dinner help to remind George why he continues to dedicate his time and effort to a program such as Miriam's House. Within the next ten years, George would love to see homelessness eradicated but believes it may become more of an issue with the aging "baby-boomer" generation due to insufficient retirement accounts and substantial cut backs in government spending, thus why he believes supporting a program like Miriam's House is so important.

A native of Richlands, Virginia, George moved to Lynchburg after receiving his M.B.A. from William and Mary in 1984 to join the investment department of First Colony Life Insurance Company. George is a Chartered Financial Analyst and currently a portfolio manager and principal of Flippin, Bruce and Porter. His volunteer service, in addition to being treasurer and a board member of Miriam's House includes the Vestry of St. Paul's Episcopal Church and the boards of Lynchburg Neighborhood Development Foundation and Lynchburg Area Development Corporation. George and his wife, Dea, have three children, a daughter who is graduate of Sweet Briar and currently living in Washington, D.C. and two sons who are students at Hampden-Sydney College.

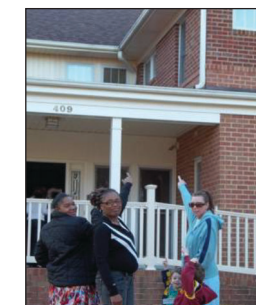
